*A final guaranteed guest count is required (1) week prior to the event. All charges will be based on the final guarantee, or the actual number of guest served, whichever is larger. All food and beverage purchases are subject to 20% service charge and 7% Maine state sales tax. The total balance is due on the day of the event.*

*No tape, tacks, nails or fasteners of any kind may be attached to any surface of Bluebird Restaurant. No confetti or silly string of any kind is allowed. The customer will be responsible for any damage or furnishing of Bluebird Restaurant. Bluebird is not responsible for any lost or stolen items.*
